



ADOPTION AGREEMENT

PARTIES:

BACKGROUND:

WHEREAS, Rescue Organization is a 501(c)(3) nonprofit rescue organization dedicated to the rescue, rehabilitation, and rehoming of dogs in need; and

WHEREAS, Adopter wishes to adopt a dog from Rescue Organization;

NOW, THEREFORE, in consideration of the mutual covenants contained herein, Rescue Organization and Adopter agree as follows:

1. ADOPTION OF DOG:

Rescue Organization agrees to transfer ownership of the following described dog (the "Dog") to Adopter:

2. ADOPTION FEE:

In consideration for the adoption of the Dog, Adopter agrees to pay a non-refundable adoption fee of \$_____ (the "Adoption Fee") to the Rescue Organization. The Adoption Fee covers the variable cost of vaccinations, microchipping, transportation, and other expenses associated with the Dog's care.

3. SPAY/NEUTER AGREEMENT:

(a) If the Dog is not old enough for spay or neuter surgery at the time of adoption, Adopter agrees to foster the Dog until such time as the Dog is of an appropriate age for the surgery through the foster to adopt program.

(b) There will be a refundable deposit required for the foster to adopt program. The deposit is determined by FTWL staff based on expenses associated with the Dog's medical care and transport. This deposit will be applied to adoption fees or paid directly to the veterinarian designated to perform spay/neuter procedure when the Dog reaches the appropriate age for the surgery upon confirmation of spay/neuter completion.

Foster to Adopt:

- The selected Dog is being placed in our foster to adopt program for one or both of the following reasons
- The animal is not fully vetted due to age or other circumstance and cannot be adopted until all vetting is complete; including but not limited to standard vaccinations, spay/neuter, or other health issues.
- Spay/Neuter eligibility date
- A home visit is needed in order to ensure proper placement of the Dog.
- Verification of spay/neuter and vetting will be confirmed by The Rescue through selected veterinarians. Once this is complete, The Adopter and The Rescue will proceed with permanent adoption.

- There is a \$_____ refundable deposit required for participation in the foster to adopt program. This fee can be applied to the final adoption fee upon completion of necessary procedures and vetting.

- _____ (initial) The Rescue agrees to provide appropriate vetting and verification of health to transition said Dog into permanent adoption.

4. CARE AND RESPONSIBILITY:

The Adopter agrees to provide proper care, shelter, and attention to the Dog. This includes but is not limited to:

- Providing adequate food, water, and shelter.
- Ensuring the Dog receives necessary medical care and vaccinations.
- Keeping the Dog in a safe and secure environment.
- Providing love and companionship to the Dog.
- Ensure that unaltered Dogs will not be used for breeding purposes.

5. RETURN POLICY:

Adopter agrees that if, at any time in the future, they are unable to keep or care for the Dog, they will contact the Rescue Organization immediately. Rescue Organization has the first right of refusal to reacquire ownership of the Dog, and Adopter will not rehome, sell, or surrender the Dog to any third party without the written consent of Rescue Organization.

6. INDEMNIFICATION:

Adopter agrees to indemnify and hold harmless From Texas With Love from any and all claims, damages, liabilities, costs, or expenses arising out of or related to the Dog's actions or behavior while in the care of Adopter.

7. ENTIRE AGREEMENT:

This Agreement constitutes the entire understanding between the parties and supersedes all prior agreements and understandings, whether oral or written.

8. GOVERNING LAW:

This Agreement shall be governed by and construed in accordance with the laws of the State of Texas.
